





# **Voting Options**

You can vote by returning the Proxy and Ballot card in the U.S. Mail, or you can now vote online! Just follow these steps:

Step 1: Go to www.blsmwc.com

Step 2: Click on the red **VOTE** button, located at the top, right-hand corner.

Step 3: Enter your 6-digit **WEB ID** number.

Step 4: Your **password** is your service address. This gives you access to the Proxy and the Ballot.

Step 5: Sign your Proxy by entering your last name, and then vote for the candidate(s) of your choice for Director.

Note: You don't have to vote, but we do need your Proxy.

Step 6: Click the **SUBMIT** button.

## **BLSMWC** Announcements

The next BLSMWC Board of Directors meeting is Thursday, July 11, 2024, 2:00 p.m., at the BLSMWC offices, 1011 Blagen Road, Arnold. All are invited to attend.

The State of California is requiring the Water Company to prepare an inventory of lead service lines in houses built before 1986. So you might see our guys this Summer doing work around your water meter box and the closest water spigot to the meter box. The BLSMWC staff will have proper identification on hand at all times, and they will <u>not</u> need access to the inside of your home.

### **More Announcements**

Has it been awhile since you've visited your house or cabin? You might want to flush your water lines to clean out any sediments that have settled over the Winter. You can do this by running an **outside** hose for a few minutes before using any water inside your home.

Please note that Invoice 2 of 6 will be due May 25, 2024. You have the option of paying your bills several different ways: mail your payment; pay in person; call (855) 738-2592 to pay with a credit card; have your bank make automatic deposits; or pay by going to www.blsmwc.com, click on the "Pay My Bill" tab to set up an automatic account.

The California Department of Water Resources, as of April 17, 2024, reports the State's average precipitation total is 107% of normal. Upper Calaveras County is 100% of normal. The snowpack shows above average for the second straight season. This is good news for us!
